PART A: STRATEGIC OVERVIEW

1. Vision

Inclusive, proactive identification and sustainable management of heritage resources.

2. Mission

Heritage Western Cape ensures and implements the inclusive identification, effective management, conservation and promotion of heritage resources for present and future generations.

3. Values

Caring, Competence, Accountability, Integrity, Innovation, Responsiveness, Inclusivity and Respect.

4. Legislative and other Mandates

Heritage Western Cape (HWC) operates within the legislative mandates on which its overall functioning is based:

- to promote good governance at all levels;
- to empower civil society to nurture and conserve the heritage resources so that they may be bequeathed to future generations;
- to lay down general principles for governing heritage resources management throughout the Western Cape; and
- to introduce an integrated system for the identification, assessment and management of heritage resources in the province in terms of the National Heritage Resources Act and its regulations.

DCAS and the MEC took corrective steps to ensure fair administrative processes and make provision for the admission of new evidence into the record of a tribunal process, as well as better compliance with the rules of natural justice in terms of the <i>audi alteram partem maxim</i> .

Piketberg Local Heritage Committee and Another v Liebco Vleishandelaars Edms Bpk and others (Heritage Western Cape 2 nd Respondent)	Western Cape Division of the High Court of South Africa No. 1103 2016	Application for review of a decision of HWC's Built Environment and Landscape Committee (BELCom). Permission was granted by BELCom to demolish a building on Erf 207 in Piketberg. The Court considered HWC's policy of requiring consultation only with registered conservation bodies and held that, as the decisions taken had the potential to affect members of the general public, broader public consultation was required. The Court found that S27(18) of the NHRA cannot be extended to require that a permit must be obtained by the developer of a building abutting a heritage site. It found further that the City of Cape Town had taken all relevant factors into consideration and that it could not accordingly review and set aside its decision.
Tower Property Fund Limited v Heritage Western Cape	Western Cape Division of the High Court of South Africa, No. 7000/2018	Application for an order lifting the stop works order which was served by HWC in relation to building work on an adjacent property, which was feared to be causing damage to the adjoining heritage resource, namely a grade IIIA church building. The Court held that HWC should have given the applicant an opportunity to respond before serving the stop works order.

5. Situational analysis

Since its establishment in October 2002, Heritage Western Cape has developed systems for the management of applications that are submitted to it in terms of the National Heritage Resources Act, 1999, and is recognised as a leading heritage resources authority in terms of this area of operations.

Over the past years, the organisation has sought to clarify a number of issues concerning its major area of operations. While it has successfully established clear rules for its operations, in particular with regards to the processing of applications, HWC is pursuing delegations to local authorities who have expressed an interest to take on functions for the management of local heritage resources. Discussions are ongoing with the Drakenstein Local Municipality to establish a framework that will enable the delegation process to unfold. HWC continues to build on its cooperative relationship with SAHRA in terms of the Memorandum of Agreement in respect of the management of sites of national significance within the Western Cape, and other matters of transversal interest.

During its strategic planning session, HWC identified the following as its key priorities:

- the re-grading of over 2 500 former national monuments for which it is responsible. However, given the limited resources within HWC, this project will be undertaken over many financial years;
- the declaration of significant heritage resources as provincial heritage sites in order to reflect the diversity of the province and the heritage of communities that were neglected in the past;
- reaffirming the relationship with municipalities and conservation bodies in order to ensure compliance with the NHRA, in particular with conditions set in permits and other records of decisions;
- Undertaking outreach programmes to communities in order to highlight the positive and stabilising effects that heritage can have in resolving social ills, creating social inclusion and building active citizenship; and
- Improving the understanding of the value of heritage resources through the use of explanatory signage.

5.1 Performance Environment

HWC is charged with the identification, protection, conservation, management and promotion of heritage resources. Due to capacity constraints HWC has primarily focused on the processing of applications and protection. A system of delegations has been revised to enable all committees to consider complex and/or controversial applications. Such committees meet on a monthly basis, while the Heritage Officers Meetings (HOMs) are held weekly. The expansion of delegations to HOMs has limited the number of items that are considered by BELCom and IACom, while HOMs might host additional meetings in order to cope with the increasing volume of applications.

The need to empower local authorities to establish Heritage Areas and Heritage Inventories has increased. In response to this, HWC has developed regulations that guide municipalities to comply with the provisions of Sections 30 and 31 of the NHRA. HWC will be assisting municipalities in order to identify Heritage Areas in their areas of jurisdiction. The promulgation of Heritage Areas will provide certainty as the requirements of Section 34 may be lifted outside of these declared areas.

In recent years there has been a steady increase in the number of applications HWC has processed. Whilst this is a positive development as it indicates greater responsiveness from the public to the requirements of heritage legislation, it has also placed significant constraints on the organisation, as the current staff component is not adequate to address the increase in the volume of work. In response to the increase in the number of applications, HWC has developed tools to facilitate greater responsiveness in the processing of applications.


HWC has developed the Heritage Information Management System (HIMS). Recent draft regulations by SAHRA, if promulgated, will significantly impact the manner in which HWC reports to SAHRA on its management of heritage resources within the Province. This may, as a consequence have an impact on the manner in which HIMS is structured. An interface solution with the South African Heritage Resources Information System (SAHRIS), developed by SAHRA, is being assessed.

The conservation of the Baboon Point Provincial Heritage Site, at Elands Bay, is being implemented through the support of the grant from the National Lottery Distribution Trust Fund. The funding is also being utilised to empower local community members to act as site officers to monitor and promote the heritage site.

During the course of the financial year a term of Council and its committees will expire. This will require HWC management to induct the new Council and assist in the appointment of new committees. In addition, the Department of Cultural Affairs and Sport has initiated a process of writing provincial heritage legislation. HWC will await the outcome of this legislative processes.

The Council had a strategic planning session where performance indicators were reviewed. This resulted in the adoption of new performance indicators that encapsulate the strategic vision of the NHRA. Such indicators will also enable better coordination and coherence with the HWC vision statement. The entity also engaged with the Department of Cultural Affairs and Sport regarding plans for 2019/20 financial year.

7.2 Risk management

Risk: Loss of heritage resources through unauthorised alteration/destruction or vandalism.

Mitigation strategy:

- A full-time legal advisor has been appointed to provide legal capacity.
- Developed generic guidelines and training for HWC officers. HWC performs inspections when transgressions.
- Facilitate and assist with inclusion of Heritage Registers in IDP/SDF (Spatial Development Framework) of local authorities as per NHRA.
- HWC officers investigates illegal works and follow up (on illegal work) and report to relevant committees established in terms of NHRA for decisions on actions to be taken by staff.
- HWC Workshops/training conducted for the municipal law enforcement officers and building inspectors.
- Incident reports are directly submitted by public to CEO of HWC which is attended to during office hours.
- Legal Advisor of HWC to communicate with the prosecution authority to enhance the ability of presenting heritage infringement cases to courts.
- Engagements with Municipalities re: preparation of Heritage inventories, to obtain buy in from Municipal Managers so that they are aware of their responsibilities with regards to safeguarding of heritage resources.
- Facilitate heritage awareness workshops with key stakeholders like host communities, conservation bodies and municipalities.
- Guidelines written and communicated to local authorities and professional associations as well as conservation bodies regarding definition of heritage resources and how to identify heritage resources.
- Developed a news page on HWC website and social media presence that creates awareness about the importance of heritage.
- Engagement with town planning of Department of Environmental Affairs and Development Planning (DEADP) to get better integration of heritage into municipal planning in order to mitigate risk to development.
- SOP for impact assessment developed with DEADP to integrate with Environmental management.

- Developed a news page on HWC website and social media presence that creates awareness about the importance of heritage
- Engagements with more local authorities to speed up the process of compiling heritage inventories. These inventories will enable municipalities and HWC to deal with permit applications professionally without delays. This will also inform the general public on the heritage resources in their municipal areas.
- In certain instances, badges are installed on provincial heritage sites.
- Interpretive signage placed for new provincial heritage sites - to create pride and awareness
- HWC encourages control of access to Rock Art sites by relevant management Authorities (eg. Farm owner, Local authorities, Heritage professionals) as part of their management plans.
- HWC processes applications and issues permits for professional removal of graffiti on rock art sites in the Western Cape
- HWC reports illegal behaviour by the public or professionals to its Council and Committees who in turn refer to CEO for decisions on prosecution.

5. Uphonoronongo Iwemeko

Ukususela oko lasekwayo ngoOkthobha ka-2002, iCandelo leLifa leMveli leNtshona Koloni lenze iinkqubo zokulawula izicelo ezingenisswe kulo lilandela umthetho iNational Heritage Resources Act, 1999, yaye lihlonitshwe njengogunyaziwe wemithombo yelifa lemveli ngokwalo msebenzi liwenzayo.

Kule minyaka idlulileyo eli ziko liye lazama ukucacisa imiba ngemiba ngokunxulumene neyona misebenzi yalo. Nangona liphumelele nje ekusekeni imigaqo eliza kusebenza phantsi kwayo, ngokukodwa ngokunxulumene nokulandeletwa kwezeloko, iHWC isajonge ukunabisela umsebenzi wayo koogunyaziwe beendawo (koomasipala) ababonise umdla wokwenza imisebenzi yokulawulwa koovimba bamafa emveli endawo. Ziyaqhube ka iingxoxo noMasipala weNgingqi waseDrakenstein zokumisela isikhokelo esiza kwenza ukuba kukwazi ukunikezelwa amagunya. I-HWC isaqhuba nokwakha intsebenziswano yokubambisana neSAHRA ngokweMemorandum yesiVumelwano ngokunxulumene nokulawulwa kweziza okanye iindawo ezikubaluleka kukumgangatho welizwe neNtshona Koloni, kune neminye imiba echaphazela iphondo nelizwe.

Kwishesoni yayo yokwenza izicwangiso zonyaka, iHWC iye yachonga ezi zinto zilandelayo njengezona zinto ziphambili:

- Ukubekwa ngokwezintlu ngokutsha kweemonyumenti zesizwe ezingaphezy kwe2 500, nto leyo engumsebenzi weli candelo. Kambe ke ngenxa yemithombo eshokoxekiley yeHWC, le projekthi iya kuthatha iminyaka eliqela;
- ukubhengezwa kwemithombo yelifa lemveli ebalulekileyo njengeziza zelifa lemveli zephondo ukuze ibonise iintlobo-ntlobo zamafa emveli esinawo kwiphondo, namafa emveli oluntu ebekade engahoywanga kwixa elidlulileyo;
- ukubethelela ubudlelwane noomasipala kune namaqumrhu olondolozo ukuqinisekisa ukuthotyelwa kweNHRA, ingakumbi imiqathango ebekelwe iipemithi nezinye iirekhodi zezigqibo;
- Ukwenza amaphulo aya eluntwini ukuze baxeletwe ngefuthe elihle nelinzisayo ilifa lemveli elinokuba nalo ekusombululen iingxaki zasekuhlalen zoluntu, ekudaleni ukuba abantu babe nobunye nasekwakheni imo yokuba uluntu luthathe inxaxheba kwizinto zelizwe; kune
- Ukuphucula ukuqonda ixabiso lemithombo yelifa lemveli ngokusetyenziswa kweesayini ezinengcaciso.

5.1 Imeko yokusebenza

I-HWC inoxanduva lokuchonga, ikhusele, ilondoloze, ilawule ize yazise oovimba bamafa emveli. Ngenxa yokungabi nabantu nazixhobo zaneleyo, iHWC ijonge ngokukodwa ukulandeletwa kwezeloko nokukhuselwa kwamafa emveli. Ihlaziyiwe inkqubo yodlulisel-magunya ukulungiselela ukuba zonke iikomiti zikwazi ukuqwalasela izicelo ezinzima kune/okanye nezirhanisayo. Ezi komiti zebhunga zidibana rhoqo ngenyanga, ngeli lixa iitlanganiso zaMagosa eLifa leMveli (HOMs) zibanjwa qho ngeveki. Ukunatyiswa konikezel-magunya kwiiHOMs kucuthe inani lemiba eqwalaselwa yiBELCom neIACom, ngeli lixa iitlanganiso zisenokubamba iitlanganiso ezongezelelekileyo ukuze zikwazi ukumelana nomthamo okhulayo wezicelo.

Sikhulile isidingo sokuxhobisa oogunyaziwe beengingqi ukuba baseke iitndawo zaMafa eMveli kune neZintlu zaMafa eMveli. Njengendlela yokuhlangabezana noku, iHWC iqulunge imigaqo esayilwayo eya kukhokela oomasipala ekulandeleni imigaqo yecandelo lama-30 nelama-31 leNHRA. I-HWC iza kuncedisa oomasipala ukuba bachonge iMimandla yeLifa kwimimandla abalawula kuyo. Ukubhengezwa kweMimandla yeLifa leMveli kiuza kunikeza isiqinisekiso nanjengoko imiqathango yeCandelo 34 inokususwa kwezi ndawo zibhengeziweyo.

Kule minyaka yakutsha nje kubonakala ukunyuka okukhulayo kwezicelo ezilandelelwe yiHWC. Nangona oku kubonisa ukukhula okuhle nanjengoko kubonisa ukuba uluntu luzithathela ingqalelo iimfuno zemithetho yamafa emveli, kukwabeke ubunzima emagxeni eli ziko, nanjengoko lingenabasebenzi baneleyo bokujongana nokwanda komsebenzi wabo. Ukujongana noku kukhula kwenani lezicelo, iHWC yenze iinkqubo zokunceda ekuhoyeni ezi zicelo.



Ukuba ibhengeziwe imigaqo eyilwayo esandula kwenziwa yiSAHRA, iya kuba nefuthe kakhulu kwindlela iHWC enika ngayo ingxelo kwiSAHRA malunga nolawulo loovimba bamafa emveli kweli phondo. Oku kunokuphelela ekubeni kube nefuthe kwindlela emi ngayo iHIMS. Kusahlolwa isisombululo esinxulumanisa neNdlela yokuJongana noLwazi olumalunga nooVimba baMafa eMveli oMzantsi Afrika (iSAHRIS) esetyenziswa yiSAHRA.

Ukulondolozwa kweNdawo yeLifa leMveli eliyiNdawo yeeMfene (iBaboon Point Provincial Heritage Site), eseElands Bay, kuqhutywa ngenkxaso yegranti evela kwiNational Lottery Distribution Trust Fund. Le mali isetyenziselwa ukuxhobisa abantu bendawo ukuba basebenze njengabakhokeli babatyeleli banike nolwazi lokwazisa le ndawo ililifa lemveli elibalulekileyo.

Kulo nyakamali, liza kuphela ixesha lokusebenza kweBhunga kunye neekomiti zalo. Oku kuza kudinga ukuba iHWC ibeke iBhunga elitsha ze incedise ekutyumbeni iikomiti ezintsha. Ngaphezu koko, iSebe leMicimbi yeNkcubeko neMidlalo liqale inkqubo yokubhala imithetho yeLifa leMveli yephondo. I-HWC iza kulinda iziphumo zale nkqubo yowiso-mithetho.



5. Situasie-ontleding

Sedert die totstandkoming van Erfenis Wes-Kaap in Oktober 2002, is omvattende stelsels ontwikkel vir die bestuur van aansoeke wat ingevolge die Wet op Nasionale Erfenishulpbronne, 1999 ingedien is. Die EWK word erken as die voorste erfenishulpbronowerheid ten opsigte van hierdie gebied.

Die organisasie het oor die afgelope jare gepoog om 'n aantal aangeleenthede aangaande sy primêre werksaamheid uit te klaar. Hoewel duidelike reëls vir die funksies opgestel is, in besonder ten opsigte van die verwerking van aansoeke, streef EWK delegasies na met plaaslike owerhede wat belangstelling uitgespreek het om funksies vir die bestuur van plaaslike erfenishulpbronne oor te neem. EWK is voortdurend in gesprek met die Drakenstein plaaslike munisipaliteit om 'n raamwerk daar te stel sodat die delegasieproses sy gang kan gaan. EWK gaan voort om te bou op sy samewerkingsverhouding met SAEHA volgens die Memorandum van Ooreenkoms ten opsigte van die bestuur van terreine wat van nasionale belang is in die Wes-Kaap en ander aangeleenthede van dwarsliggende belang.

Gedurende sy strategiese beplanningsessie het EWK die volgende as sy hoofprioriteite geïdentifiseer:

- die hergradering van meer as 2 500 voormalige nasionale monumente waarvoor dit verantwoordelik is. Gegewe die beperkte hulpbronne van EWK sal hierdie projek egter oor talle boekjare onderneem word;
- die verklaring van beduidende getalle nuwe hulpbronne as provinsiale erfenisterreine ten einde die diversiteit van die provinsie en die erven van gemeenskappe wat in die verlede verwaarloos is, te weerspieël;
- herbevestiging van die verhouding met munisipaliteite en bewaringsliggame om nakoming van die Wet op Nasionale Erfenishulpbronne, in besonder met voorwaardes wat in permitte en ander rekords van besluite gestel word, te verseker;
- die onderneming van uitrekprogramme vir gemeenskappe wat die positiewe en stabiliserende effek van erven verlig om maatskaplike euwels op te los, maatskaplike insluiting te bewerkstellig en aktiewe burgerskap te bou; en
- om die begrip van die waarde van erfenishulpbronne deur die gebruik van verduidelikende naamoorde te verbeter.

5.1 Prestasie-omgewing

EWK is belas met die identifisering, beskerming, bewaring, bestuur en bevordering van erfenishulpbronne. Weens kapasiteitsbeperkings het EWK hoofsaaklik op die verwerking van aansoeke en beskerming gefokus. 'n Stelsel van delegasies is hersien om al die komitees in staat te stel om ingewikkelde en/of omstrede aansoeke te oorweeg. Sulke komitees ontmoet op 'n maandelikse grondslag, terwyl die Vergaderings van Erfenisbeamptes (VEBs) weekliks gehou word.

Die uitbreiding van delegasies aan VEBs het die getal items wat deur BELCom en IACom oorweeg word, beperk terwyl VEBs bykomende vergaderings kan belê om die toenemende volume van aansoeke te hanteer.

Die noodsaaklikheid om plaaslike owerhede te bemagtig om erfenisgebiede en erfenisinventariste in te stel, het toegeneem. In reaksie hierop het EWK konsepregulasies opgestel wat vir munisipaliteite leiding sal gee om die bepalings van artikel 30 en 31 van die Wet op Nasionale Erfenishulpbronne na te kom. EWK het reeds begin om munisipaliteite te raadpleeg om erfenisgebiede in hulle regssgebiede te identifiseer.

Die proklamering van erfenisgebiede sal sekerheid verskaf aangesien die vereistes van artikel 34 buite hierdie verklaarde gebiede opgehef kan word.

Die aantal aansoeke wat deur EWK verwerk word, het die afgelope paar jaar bestendig toegeneem. Terwyl dit as 'n positiewe verwikkeling beskou word aangesien dit op die publiek se groter wordende optrede in ooreenstemming met erfeniswetgewing duï het dit ook groot stremming op die organisasie geplaas, aangesien die huidige personeelkomponent nie voldoende is om aandag te gee aan die verhoogde hoeveelheid werk nie. EWK het metodes ontwikkel om groter responsiwiteit in die verwerking van aansoeke moontlik te maak.


EWK het die Erfenisinligtingbestuurstelsel (EIBS) ontwikkel. Indien die onlangse konsepregulasies deur die SAEHA gepromulgeer word, sal dit 'n beduidende impak hê op die manier waarop EWK aan die SAEHA verslag doen oor die bestuur van erfenishulpbronne binne die provinsie. Dit kan gevvolglik 'n impak hê op die manier waarop die EIBS gestructureer word. 'n Koppelvlakoplossing met die Suid-Afrikaanse Erfenisshulpbron-inligtingstelsel (SAEHIS) wat deur SAEHA gebruik word, word tans geassesseer.

Die bewaring van die Bobbejaanpunt Provinciale Erfenisterrein by Elandsbaai word tans geïmplementeer deur middel van 'n toelae deur die Nasionale Lotery-verspreidingstrustfonds. Die befondsing word ook aangewend om lede van die plaaslike gemeenskap te bemagtig om as terreinbeamptes op te tree om die erfenisterrein te monitor en te bevorder.

Die ampstermy van die Raad en sy komitees sal in die loop van die boekjaar ten einde loop. Daar sal van die bestuur van EWK verwag word om 'n nuwe raad aan te stel en behulpsaam te wees met die aanstelling van nuwe komitees. Daarbenewens het die Departement van Kultuursake en Sport 'n proses van stapel gestuur om provinsiale erfeniswetgewing op te stel. EWK sal op die uitkoms van hierdie wetgewende proses wag.

Sulke aanwysers sal ook beter koördinering en samehang met EWK se visieverklaring verseker.
