## **SUMMARY ON THE STATE OF LOCAL GOVERNMENT REVENUE AND EXPENDITURE: THIRD QUARTER CONSOLIDATED STATEMENT FOR THE PERIOD 1 JANUARY 2025 - 31 MARCH 2025**

### **A. BACKGROUND**

This publication complies with the requirement in section 71(7) of the Local Government: Municipal Finance Management Act (No. 56 of 2003), that the Provincial Treasury must publish a consolidated statement on the state of municipal budgets. The consolidated statement reflects the financial performance of municipalities as at the end of the third quarter (ending 31 March 2025) of the 2024/25 municipal financial year. The performance reporting for this period presents the 2024/25 municipal budget performance outcomes and is subject to change with the finalisation of the municipal Annual Financial Statements (AFS).

This publication forms part of the In-Year Management, Monitoring and Reporting System for Local Government which enables the Provincial Treasury (PT) to exercise oversight over municipalities in the Western Cape. It provides a high-level review of the implementation of municipal budgets for the third quarter, ending 31 March 2025.

### **B. DATA USED**

National Treasury's Local Government Database is the primary data source used for this publication. The quality of the report is subject to the credibility of the municipal Standard Chart of Accounts (mSCOA) data string information submitted by the tenth working day of each month and is compromised when municipalities fail to submit all the required data strings.

Some anomalies were noted in the submissions made by municipalities which have a significant impact on the credibility of the financial information reported for the period ending 31 March 2025. Discrepancies on key indicators were observed on the negative cash and cash equivalent budgets and year-to-date actuals reported by some municipalities as well as misalignments on capital funding and expenditure.

To assist municipalities to submit credible mSCOA data strings, PT has institutionalised an mSCOA segments use analysis tool which is shared with municipalities on a monthly basis. PT also has technical engagements with municipalities to discuss mSCOA findings. Municipalities are required to develop an action plan indicating specific timelines to resolve issues identified so that PT can keep track of the progress made by municipalities monthly.

Despite the challenges, Western Cape municipalities are committed to improving the quality of information with support from the National and Provincial Treasuries.

The data presented in this publication provides a summary of the budget implementation performance against key indicators for all municipalities in the province. The data used was extracted on 15 April 2025 and detailed information for each municipality is available to the public in the section 71 files published at [mfma.treasury.gov.za](http://mfma.treasury.gov.za).

### C. AGGREGATED TRENDS

1. In aggregate, Western Cape municipalities spent R73.13 billion or 63.7 per cent of the total adjustment expenditure budget of R114.72 billion by the end of the third quarter ending 31 March 2025 (actual operating expenditure accounted for R64.15 billion and actual capital expenditure for R8.98 billion).
2. In respect of revenue, aggregate billing and other revenue amounted to R82.19 billion or 71.9 per cent of the total adjustment revenue budget of R114.27 billion (actual operating revenue accounted for R73.57 billion and actual funds utilised to fund the capital budget amounted to R8.62 billion).
3. Service charges and property rates are the largest revenue sources, contributing 48.2 per cent and 17.8 per cent, respectively, towards the total YTD operating revenue generated of R73.57 billion. This is consistent with past trends.
4. For the quarter under review property rates overperformed by R117.13 million or 0.9 per cent against the Year-to-Date (YTD) budget of R13 billion. Furthermore, an overperformance from service charges of R147.46 million or 0.4 per cent against the YTD budget of R35.33 million is noted.
5. To date, municipalities spent R64.15 billion or 66.6 per cent of their aggregated operating expenditure budget of R96.35 billion. Inventory consumed and bulk purchases is the highest cost driver, amounting to R22.64 billion or 35.3 per cent of total operating expenditure to date, followed by employee related costs of R19.94 billion or 31.1 per cent and other expenditure amounting to R15.52 billion or 24.2 per cent.
6. Aggregated operating expenditure underperformed by R3.35 million or 5 per cent against the year-to-date operating budget as at the end of March 2025. A year-on-year comparison indicates an increase in operating expenditure of R7.31 billion or 12.9 per cent, compared to the same point last year.
7. As at the end of March 2024, an aggregated operating surplus of R9.42 billion was reported against a year-to date budgeted surplus of R5.14 billion. However, it was noted that several municipalities are not fully reporting on their non-cash items (debt impairment and depreciation), this significantly understates the operating expenditure reported to date and results in an exaggerated operating surplus.
8. Municipalities in the Western Cape spent R8.98 billion or 48.9 per cent of their aggregated R18.37 billion capital budgets to date. Spending on capital remains slow with an underperformance of R2.43 billion or 21.3 per cent when compared to the budgeted year-to-date performance. Capital expenditure commitments were reported to be R4.09 billion of which R2.93 billion relates to the City of Cape Town. When commitments are considered, capital expenditure is 71.1 per cent of the total aggregated adjustment capital budget of R18.37 billion. Encouragingly, a year-on-year comparison reflects that capital spending by municipalities increased by R1.39 billion or 18.3 per cent compared to the same point last year.
9. The City of Cape Town reported capital spending of R5.93 billion (49.5 per cent of the adjustments budget) which is an underperformance of 16.6 per cent against the year-to-date budget. Secondary cities (Drakenstein, George and Stellenbosch municipalities) reported aggregated capital expenditure performance of R1.29 billion or 44.5 per cent against their combined capital budget of R2.90 billion. Local municipalities' capital spending amounted to R1.61 billion or 52.6 per cent against their aggregated capital budget of R3.05 billion. Municipalities' capital spending is largely dependent on the timeous planning and completion of supply chain processes such as advertisement of bids and evaluating and awarding contracts to successful bidders.

10. In aggregate, Western Cape municipalities planned to fund 64 per cent of their total capital investment from own funding, a slight increase from the 63.5 per cent budgeted in the prior year. To-date capital investment from own funding comprises of borrowings (47.9 per cent) and internally generated funds (19.2 per cent).
11. Capital spending funded from borrowings to-date amounted to R4.13 billion or 48.9 per cent of the adjusted budgeted borrowings of R8.45 billion. This includes borrowings from the City Cape Town of R3.58 billion against its YTD budgeted borrowing of R4.39 billion.
12. Capital spending funded from transfers to-date amounted to R2.84 billion or 43.2 per cent of the adjustments budgeted amount of R6.57 billion. Internally generated funds utilised to-date amounted to R1.65 billion or 50.9 per cent of the adjusted budget of R3.25 billion.
13. It was also noted that 6 (six) municipalities in the province reported capital expenditure that does not reconcile to the reported capital funding utilised.
14. The aggregate municipal consumer debtors balance as at 31 March 2025 amounted to R15.67 billion. The bulk of the outstanding debt is owed by households, which account for R10.77 billion or 68.7 per cent of the total outstanding debt. Debtors older than 90 days amounted to R10.38 billion or 66.3 per cent of the total outstanding debtors. This includes historic debt that has accumulated over an extended period, interest on arrears and other recoveries.
15. Quarter-on-quarter outstanding debtors decreased by R690.39 million or 4.2 per cent, from the R16.36 billion reported at the end of the December 2024. Debtors over 90 days decreased by R540.18 million or 4.9 per cent during the third quarter.
16. In aggregate, Western Cape municipalities reported outstanding creditors of R898.65 million as at 31 March 2025. Outstanding creditors older than 30 days amounted to R440.22 million or 48.9 per cent of the total outstanding creditors. Total outstanding creditors have increased by R155.45 million or 20.9 per cent when compared to the outstanding creditors of R743.20 million reported as at the end of December 2024. Municipalities cited various reasons for payments that are owed for more than 30 days.
17. Three (3) of the four municipalities are currently in compliance with the Eskom National Debt Relief Programme. However, one (1) municipality in the Western Cape failed to adhere to the programme's conditions, resulting in the issuance of breach notices in January 2025. In response, the Provincial Treasury has met with the municipality to address the non-compliance. Furthermore, one (1) municipality, which is not participating in the debt relief programme, received a breach notice from Eskom in March 2025 due to payment defaults. Payment arrangements are being negotiated with Eskom to address both current and arrear account balances.
18. Provincial Treasury will continue to provide support to municipalities including guidance and support with mSCOA implementation, budget verifications, annual budget and in-year monitoring workshops, and other Intergovernmental structures in conjunction with various government departments
